Class of '20 Grad., Galloping Ghost Selected Walter Camp All Americans

George R. Pfann, CMA Class of 1920 and Red Grange were selected Walter Camp First Team All Americans in 1923. George, at 5 ft. 9 in. and 172 lbs. was quarterback at Cornell while the Galloping Ghost played half-back for the University of Illinois.

It was the era of the single wing and the quarterback was often called the blocking back, but he also had to carry the ball on plunges into the line and was sometimes used as a pass receiver.

Cornell/Pennsylvania Rivalry

In Pfann's three years as a starter, Cornell won all 24 of its games and scored 1,051 points against 81 for its opponents. The school's most important games were against the University of Pennsylvania.

In 1921, Pfann was featured as a blocker in front of Edgar Kaw, who scored 5 touchdowns in a 41-0 victory. Pennsylvania was watching for Kaw in 1922 and Pfann did most of the ground gaining as Cornell won, 9-0.

Pfann, captaining the team in the fall of 1923, caught a 30-yard pass for one touchdown and ran 5

yards for the other as Cornell again beat Penn, 14-7.

George Trevor of the New York Sun put Pfann on the all-time All-American team he selected in 1938. Pfann was inducted into NCAA Hall of Fame in 1957 and the Ivy League Football College Hall of Fame.

While at CMA, George lettered in both football and baseball.

Coached/Studied Law

After obtaining his undergraduate degree at Cornell, Pfann studied law there while acting as assistant coach in football and basketball. He then spent a year as a Rhodes Scholar at Oxford, England, the first All American football player to do so.

In addition to football, Pfann played basketball and Lacrosse at Cornell and Rugby and Lacrosse at Oxford..

He practiced law both privately and as Assistant U. S. attorney for the Southern District of New York from 1928 to 1941. He also coached football at Swarthmore from 1931

Class of '52 Grad to Ole Miss Hall of Fame

Cecil Burford, Jr., Class of '52 was inducted into The University of Mississippi M-Club Athletic Hall of Fame last September.

Cecil made his mark on the baseball field as a standout pitcher for the Rebels. A two-time letterman in 1956 and 1957, Burford helped elevate the Rebel baseball program to new heights, including a College World Series appearance in 1956.

In that run to Omaha, he claimed Most Outstanding Pitcher honors in the 1956 NCAA District III Finals as he helped the Rebels defeat Tennessee

Tech and Duke. In that '56 season, he also hit another mark that few pitchers have been able to repeat as he no-hit Vanderbilt in a 7-0 win. He is one of only five pitchers to toss a no-hitter in Rebel baseball history.

In his two years in a Rebel uniform, Burford helped the Rebels to a 40-18 record as Ole Miss burst onto the national scene.

"It was indeed very humbling and overwhelming to receive the telephone call that I had been selected for induction into the M-Club Athletic Hall of Fame," Burford said.

through 1935.**

On Patton's Staff

During World War II, Pfann was on Gen. George S. Patton's staff and was involved in a history making event as the Third Army rolled across Germany.

German General Günther von Kluge faced Patton's advance on the Western front as commander of Army Group West. Kluge was involved in the assassination plot against Hitler about this same time.

The story goes that Kluge, having heard the news of the explosion designed to kill Hitler at Rastenberg, stated: "If the Fuhrer is dead, we ought to get in touch with the other side at once."

Kluge Contacts Patton

Discovering almost immediately that the attempt on Hitler's life had failed, Kluge decided to contemplate surrender anyway. He then supposedly contacted Patton for a meeting and was absent from his headquarters the entire day of August 15, 1944.

Captain Pfann, secretary to General Patton, later revealed that Patton had also vanished the same day and that the American general had tried to make contact with a German emissary who had not appeared at the appointed place.

According to Kluge's official report explaining his absence, an allied fighter pilot spotted the General's staff car and accompanying radio truck, strafed them and destroyed the radio. Being unable to contact Patton, Kluge returned to headquarters.

Transmission Intercepted

At the fuhrer headquarters, an American radio transmission was intercepted asking for Kluge's whereabouts. It was Patton trying to locate Kluge.

Hitler, immediately suspicious of Kluge, fired him demanding he return to Germany immediately, but Kluge sensing his execution was imminent, took his own life.

Pfann indicated in a letter to Col. W.O. Batts Jan. 24, 1952 that he had

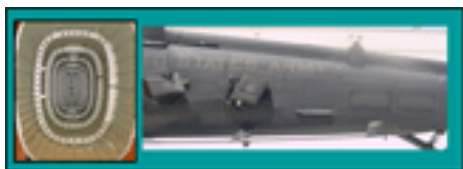
72 Graduate Wins 3rd National Tech. Award

Greg Thompson, class of '72, won his third national award for his work in the area of advanced composite materials.

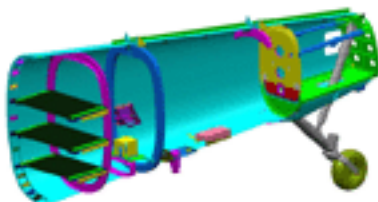
At the annual Defense Manufacturing Conference held 3-7 Dec. at the Paris Hotel, Las Vegas, NV, Greg, along with his teammates, were awarded the 2007 Defense Manufacturing Excellence Award. The citation reads this award is "In recognition of his outstanding and dedicated service to Defense Manufacturing Technology Excellence" as a member of the Common Composite Tailcone (CCTC) Program. The award was provided jointly by the National Center for Advanced Technologies (NCAT) and the Association for Manufacturing Technology (AMT).

The Common Composite Tailcone is currently in the final phase of qualification testing for use on the UH-60M Upgrade helicopter and will replace the legacy metallic structure.

The benefits include: two major part construction (left and right halves), the removal of 5 frames, 29 full length ribs, 9,000 fasteners and 46 pounds of aircraft weight. The metal baseline is shown on the left and the composite design is shown on the right (right side only shown). This project also won the 2005 American Helicopter Society Robert L. Pinckney Award for in recognition of notable achievement in manufacturing research and development for rotorcraft of rotorcraft components brought to fruition in recent years. The Award was created by Boeing in 1995 to honor the memory of Robert L. Pinckney, an eminent manufacturing engineer.

run into several CMA classmates during WWII. Mentioned were Lonnie Nathan and Herbert Toomey.

In addition to campaigns in France and Germany, he was with the Western Task Force in North Africa, involved with Patton in the Sicily invasion and served in the office of the Secretary of War following VE Day. He received the Legion of Merit and the Bronze Star during his tour of duty and in December of 1944 was promoted to Lt. Colonel.

Retired in 1964

After the War he returned to the practice of Law, representing the Cooperative Grange League Federation Exchange, Inc. in Ithaca, NY, as general council until his retirement in 1964.

Pfann and wife Louise, returned to CMA on several occasions in ensuing years. He contributed to the general school fund and represented the Class of '20 in its Alumni Association. He gave the CMA commencement address to the Class of '68 and returned for the Homecoming football game in 1969.

George Pfann died in December of 1996.

Buford D. Abernathy, Class of '38

Commander Buford D. Abernathy, USN (Retired), age 88, of Louisville, KY died at his home February 27 after a long illness.

He won an appointment to the United States Naval Academy in 1938, by competitive examination, having stood seventh on the list of all competitors from all Honor Military Service Schools nationwide.

While Abernathy's Annapolis graduating class is listed as 1942, he was accelerated to graduate December 19, 1941, after World War II was declared. On receiving his commission, he immediately reported and served in the Pacific theatre.
