Reminder to Pay your Dues to the Alumni Association



Harold D. Church, Class of '37

Harold D. Church, a life-long resident of Maury County, was born February 9, 1919 and died Friday, February 5, 2021 peacefully at Magnolia Healthcare in Columbia. He was the son of the late Clayton Forgy Church and Nora Dene Shaw Church, and the grandson of the late State Senator John W. Church. He was preceded in death by his parents and brother, John Clayton Church, Sr. His education began at the Athendale and McDowell Elementary Schools, continued with Columbia High School and graduated from Columbia Military Academy. His college education was from Andrew Jackson Business College in Nashville, TN with a two-year Associate Business degree. Bill and Sibyl were married in 1952 and moved to Oak Ridge, Tenn., in 1953 so that Bill could attend the Oak Ridge School of Reactor Technology (ORSORT). formal academic credentials, including a doctorate in physics, were earned at Vanderbilt University, but the ORSORT diploma proclaiming him a DOPE (Doctor of Pile Engineering) was one of his prized possessions. After Bill graduated from ORSORT, he and Sibyl moved to Livermore, Calif., where he worked at the newly established Livermore Radiation Laboratory. They returned to Oak Ridge in June 1955, where Bill joined the Reactor Experimental Engineering Division of ORNL. He retired in 1992, but returned to ORNL as a consultant in 1993, working closely with Subramanian Raman for several years on nuclear structure physics. Bill is survived by five children and their spouses: Nell Nestor and Steve Yeldell, Bonnie Nestor and Charles Crume, John Nestor and Theresa Donahoe, Will Nestor and Karen Oakley, and Anne Nestor and Alan Cady; nine grandchildren: and five greatgrandchildren.
