President Kimbrell thanked all members attending for their effort to travel to the meeting. Several members were unable to attend due to the weather and flooding in the Tennessee area.

CA President

Dr. James Thomas, President of Columbia Academy, welcomed the Board and thanked us for our continued use of Columbia Academy Campus for our meetings. Dr. James thanked the Alumni Association for the \$5,000.00 donation to the Academy Hall Repair Project. He told us the fund raising is in progress. The roof repair estimate is \$63,000. CA was awarded a grant from the State of Tennessee for \$25,000, and CMAAA has donated \$5,000.

CA will apply for a grant for repair to the roof of Frierson Hall, which is not in use at this time.

Dr. Thomas gave the Board an

update on CA. There are presently 650 students enrolled, which is down by 40 from last year. The enrollment is expected to remain stable at this time. A satellite campus for Spring Hill has been approved which will be used for Kindergarten through 6th Grade.

Dr. Thomas told the Board CA was looking forward to our Reunion in August, and they would help in any way possible.

A motion was made, seconded and approved to accept the minutes from the Aug. 29, 2009 Board meeting, as published in the Winter, 2009 Bugle.

duty. "He left as a corporal and after three tours of war time duty on the front lines, 2 in Iraq and 1 in Afghanistan. He was injured during his last tour of duty by a road side bomb that took the front of his humvee off. His buddies in the drivers seat and passenger shotgun seat were OK only suffered broken legs, no limbs lost, no lives lost. My son was in the turret and suffered severe gashes to the left elbow and left knee. We are very proud of him and his service to our country. He is my hero," says John.
