**Meeting Minutes**

The fall meeting of the Columbia Military Academy Alumni Association was called to order by President Mike Gilchrist. The Pledge of Allegiance was led by John Bass, followed by the invocation led by Randy Howell. The minutes for the October 17, 2015 were distributed. A motion was made and approved to accept the minutes as written.

The Treasurer's report was presented by Becky Moon. The current balance in the general fund is \$24,876.07. The difference from the October 17, 2015 report is the cost of generating and distributing the two *Bugle* editions during that period. Woody Pettigrew gave us the 2015 end-of-year financial statement for the museum. The end of year cash on hand balance for the museum fund is \$19,532. Through our budgeted income and budgeted expenses through the life of the lease the balance will be \$16,456. At the previous meeting it was decided to use the museum account to pay for the addition to the memorial, with the amount to be paid back from the general fund at a later date. An expense of \$2,750 is included on the museum report; a reflection of a 50% payment for the memorial upgrade. We will pay the remainder of the balance upon delivery. In addition Woody pro-

vided documentation of the usage of the museum funds since 2009, including a year by year breakdown of the income and usage of museum funds. Motion was made, seconded and approved to accept both financial statements.

Mike Gilchrist expressed Dr. James Thomas' regretted absence, but did relay Dr. Thomas' thanks for the presentation by Bill Wade '68, of one of the CMAAA pens created by Greg Thompson '72. A narrative of the presentation to Dr. Thomas will appear in the next edition of *The Bugle* (see page 4).

**Columbia Academy Welcome**

Ms. Lisa Bennett, Columbia Academy Vice President for Development, welcomed the association to the campus and once again reminded us that the administration of Columbia Academy enjoys our presence and our love for the two schools and their heritage. She relayed the following to the board: As of the day of the meeting there are only five weeks remaining until the graduation of the Class of 2016. CMAAA was thanked for once again awarding the scholarship for a chosen graduate, as it continues to show to the families of the students the connection the school has with our association. Many road improvements have been made to the campus. The roads have been widened and enhanced all across the campus. This was aided by a donation to the school. CA also received a donation to purchase a new bus which will be of great assistance in transporting the various sports teams. CA has also addressed some safety issues. The school now employs a new Director of Security, an experienced law enforcement officer. They also received a donation to add security access to the buildings. Those improvements will be added to both the Columbia and Spring Hill campuses during the summer break. Over spring break Mrs. Bennett and her husband Jon, who is the Upper School Principal, were in charge of a mission trip in which 42 students and 10 adults went to an orphanage in Mexico. Columbia Academy has now been designated as an Arboretum. John Rhodes, a CA student, working on becoming an Eagle Scout went through the campus and identified at least 30 different varieties of trees. This was CA's largest year for total enrollment with just above 950 students at both campuses. There is

actually a waiting list or some of the classes. The projected 2016-17 enrollment is 975. As of April 8, CA has maintained the schools accreditation. This is ongoing since 1979. The 2016 Senior Class will have 41 graduates. There are approximately 300 students in the high school. Local codes representative have met with an architect to study the possibility of using the old armory for new classroom space. At this time the school has received no official answer to the possibility. Another space to be considered is the current cafeteria, but that would generate the need to erect another building to house the cafeteria and potentially a fine arts building. An elevator has been added to the lower school building that will accommodate handicapped students. An elevator will also need to be added to the upper school.

**Old Business**

Mike Gilchrist provided an update to the photo negatives. He has spent some time going through the negatives, primarily focusing on the classes of 66 and 67, those being the classes that will have their 50<sup>th</sup> reunions during the 2016 Grand Reunion. Most of the photos are individual shots, although he was able to find the composites for 1957 and 1967. David White is now back in business at his home, so he will still be able to make prints for individuals who would be interested in having those prints.

Woody opened a discussion regarding the updates to the front sides of the two new pillars on the memorial. Numerous recommendations were made and discussed. After discussion, a motion was made and passed that the memorial would include a chronological history of CMA on the two pillars. Details of that will be developed with the plan being to have the pillars in place by the 2016 Grand Reunion. Woody proposed, and the association affirmed, to pay for these additions with museum funds.

Van McMinn proposed that the families of Hall of Honor inductees be notified prior to the induction to allow them to plan to attend the ceremony, while still maintaining the confidentiality of the selection process. The motion was made, seconded and passed that these notifications be made once the selec-

tions are completed.

Mike Gilchrist stated that everything is coming together well for the 2016 Grand Reunion at the Cools Springs Marriott. He proposed, and the association agreed, to have David White take the reunion group photos this year. Discussion was held regarding the best place to have the group photos made since there are individuals that are at the morning meeting that will not be at the dinner. A motion was made and approved to use both the museum and the reunion location for the group photos in order to accommodate as many as possible.

Heavy hors d'oeuvres will once again be available at the Friday night reception. A bar will be provided in the reception area instead of using the hotel bar as was done in the past.

Due to having a number of attendees attend the dinner that had not paid, a decision was made to have each prepaid attendee for the Saturday night dinner provided with a sticker indicating they have paid for the dinner. Only those with a sticker will be served dinner to avoid individuals from walking in and eating for free. It was also decided to add a \$5.00 per person cost for those who do not pay until the night of the dinner. Notification will be made at registration but not added to the *Bugle*.

There were some issues with the online registration process. Woody will check into the process to confirm it is working properly. (Instructions revised)

As a segue regarding the mailing of the *Bugle*, clarification was made that only those who have paid their dues by December 31, 2016 will receive hard copies for the upcoming year. An announcement will be added to the *Bugle* notifying association members.

### **New Business**

Robin Salze handed out a copy of current Board of Director guidelines, along with potential revisions in the bylaws regarding the selection of board members. This included potential changes that would remove maximum and minimum numbers for each 5 year period, as well as revising the selection process to be on a volunteer basis. The current wording of the bylaws will be revised and provided for review by the board before final approval at the next board meeting.

Ron Nall will be stepping down as the primary representative from the class of 1961. He introduced Bob Hardin as a new representative for the class.

Bill Wade said in a discussion with a former member of the CA board of directors asked if we possibly assemble videos of CMA alumni giving a short talk of what it was like to be a cadet at CMA. Mike suggested David White might be interested in doing the videos. Winston Elston also suggested there are parade videos that might be made available.

Marshall Cranford challenged the association to be more active in helping Woody with the upkeep of the museum. He suggested we develop a schedule of maintenance. Primary care of the facility has fallen on Woody, who does not live in Maury County. Several members agreed to be more available, and friend of the association, Becky Logue, also volunteered to help with the museum. There will be a work day scheduled prior to reunion weekend.

Bill Raiford went into the records room and picked up four card files of former CMA attendees who had at one time expressed an interest in forming an alumni association. Bill requested some help in compiling a mailing list from these files to send out a request for involvement in the association. The files will be cross-referenced with Becky's current list.

Prior to adjournment a blessing was asked for the meal after the meeting.

A motion was made, seconded and approved to adjourn.

### **CMA Memories Great Stories from the History of CMA**

Reference the story by John D'Armonds about the CMA band trip to Mardi Gras in February of 1963. I and my three NCOs (Barnes, Damron and I can't remember the name of the third) were the military personnel along with some CMA teachers and wives that were the so called chaperones for the 100 plus cadets. We arrived by buses in New Orleans about noon and went to our hotel to get ready for our adventure in New Orleans. After getting everyone in a room, I went to meet a blind date that one of the Drill Team members (John Baker, class of '63) had arranged. When I returned about 1500 hours, Sergeants Barnes and Damron were waiting to tell me of that visit to a nearby bar where a couple of cadets were having a drink or two. I told them to go to all the cadets' rooms and collect all the liquor they found. I knew if I reported it to the school faculty the cadets would probably be expelled. An hour or two later they came back with two overnight bags full of liquor. They never told me what they did with the liquor. Incidentally, this blind date I had there has been my wife for 52 years. Also, I graduated from CMA in 1954 and had returned for ROTC duty for 15 months. I was a Captain in the US Army at the time of this incident in New Orleans. I retired as a Colonel in 1985 and now live in San Antonio, Texas. I have told this story on numerous occasions and always get a wondering laugh from those who hear it. I am glad someone has confirmed what happened — many have doubted such young men could obtain so much liquor in so short a period of time.

I started CMA in the Fall of 1950 as a Junior. I was from Ohio and rapidly learned that I was either a "Yankee" or a "Damyaukee." I arrived a few days early, before classes began. This worked to my advantage as I was assigned to North Black Hall, lower floor. There were already two cadets there—"oldtimers" who had arrived early.

They were C. A. Wilkins and Tom “MAC” McCarthy. They were roommates and I believe they had been at CMA for two or more years. At any rate, they taught me a lot, to include some basic drill movements. So I had some advantage over the other “new” guys. I enjoyed CMA from the very beginning, although it was obviously a big change in my life. My parents had always lived in the country which meant I was always short on playmates and friends my own age. I was the son of two school teachers and I had very little in common with the sons of farmers, which was what all our neighbors were. CMA was great. I now had friends my age that were present 24 hours a day! We all had something in common—learning and practicing survival in a military atmosphere. I particularly enjoyed the “bull sessions.” There were many in North Black, and it seems as if the room of Wilkins and McCarthy served as “Bull Shooting Central.” The King of the BS’ers had to have been Angelo Mistilis, from Oxford, MS! (That opinion has absolutely nothing to do with this tale.) We, of course, discussed the glories of adult beverages—the consumption of which was a serious offense at CMA—always resulting in expulsion. I had tasted beer in my lifetime, but I don’t think I had ever consumed more than a sip that my Dad gave me on several occasions. Of course, I would never admit that my experience level was so low—especially around a bunch of Southern boys, all of whom supposedly were experienced drinkers at their early age (at least to hear them tell it). One weekend it was decided that we should “drink a little beer.” We would find a cab driver who would purchase a case of beer and drop us at a creek location already known by some of the old cadets. We would enjoy the beer and return to school. Sounded like a great idea to this 15 year old. So, Saturday night came, we signed out for town, and grabbed a cab. Everything went according to plan. We hauled the beer from the cab to the creek location, started a bonfire, and then commenced to have a few. Man, that first bottle tasted so good! So, time for another one. I was about half way through that second bottle when I started to feel strange. I got up, (probably to relieve myself) and I noted that I was

dizzy and feeling really weird! Tom McCarthy soon determined that I was drunk! Now what was I going to do? No way was I going to sober up prior to sign in time. I certainly could not afford to be caught intoxicated--resulting in expulsion. Tom McCarthy came to my rescue! He said: “We will go back right now .” Mac continues: “When we get back, you go to bed. C.A. and I will wait until almost the deadline and we will report back in.” Captain Batts was on duty that night. Mac elaborates: “When I report in, I will ask Captain Batts if Cadet Williams had reported back. When Batts says NO, I will tell him that Williams got sick when we were all downtown, he came back early, and I bet he went to bed (or some such tale).” Well, that is what occurred. I, of course, was not a witness to the great acting job done by McCarthy, but it was effective. I remember that the door to my room opened and Captain Batts stuck his head in to make sure I was, in fact, present and in bed. I acted like I was asleep. Fortunately, Capt. Batts did not enter the room—he would have smelled the beer on me, I am sure. That was a close call! I never again partook of adult beverages while at CMA. I often thought then, and still do, how terrible it would have been if I had been caught and expelled. My parents were not wealthy—it was taking my Mom’s entire salary to pay for my schooling. Also, if I had been expelled, my Dad would have been in a very difficult position. As a school teacher in the public school that I normally would have attended, I am sure he already had to defend his actions—sending me to a private school. If I had been expelled, his position would have been untenable. I will forever be indebted to Tom McCarthy for saving my ass. He knows it. I tell him that frequently!

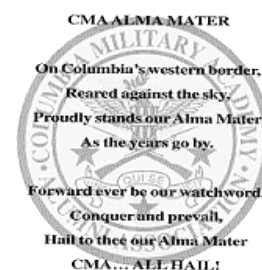

(I am pretty sure it was that trip that the bus broke down; if someone remembers differently I will not be terribly surprised.) Hard to believe that was 43 years ago. What a night.

# Then and Now

## Herbert Eustis, Class of '67

Herbert Eustis grew up in Greenville, Mississippi. When his father died, his mother felt Herbert should attend CMA with several others from the Mississippi Delta. Ben Hand, Charles Harrison, and George Archer were among the cadets who traveled with him from Greenville to Memphis and Nashville via Southern Airways, then caught a bus for the final leg to Columbia. Herbert attended CMA from 1964 to his graduation in 1967. He was a Cadet Lieutenant Colonel and Assistant Battalion Commander. He was elected President of the Junior Class, President of the Senior Class, and Mr. CMA. Herbert was on the track team (for only one race-- a quick burst in the 440 sputtered to a last place finish. Capt. Rada-baugh remarked, "Eustis, you're not in shape!!"), participated in Hi-Y, Junior Civitan, the Dance Committee, Gold Star Drill Platoon, Chess Club, Armory Staff (Herbert swept the floor almost everyday) and Recall Staff. He was a member of the Top Five for two years. He was also inducted into the CMA Hall of Fame. Herbert lived in South Black with roommate Cole DeWees and a great group of guys on the first floor. Andy Glogower, another South Black resident, wore a smoking jacket while he enjoyed a pipe. Bruce Crawford, a big CMA swimmer, was also on the hall along with his roommate (and Herbert's cousin) George Archer. Capt. Cathey, the faculty member who lived



on the second floor of South Black, left a lasting memory with Herbert. Capt. Cathey, attired in full uniform of jodhpurs, tall boots, and crop, walked the halls during the nightly study hall. He was accompanied by his German Shepherd who faithfully followed his strict command, "*Vance, kommen sie her!*". Herbert remembers Col. Wilhoite, who taught Spanish II in the afternoon to a small group of cadets. The Colonel walked and moved slowly. One hot afternoon the windows were up, allowing a fly to come in, land on his nose, and fly away. In the amount of time it took the Colonel to reach up and attempt to swat the fly, it returned and flew away a second time. Col Wilhoite then chuckled, allowing the entire class to join him in uproarious laughter. CMA taught Herbert skills that were useful to him throughout his lifetime. Discipline, along with the ability to listen and compromise, benefitted him with dealing with people in his real estate business. He says he is most appreciative of his teachers who helped mold him into a young man, well prepared for college and beyond. Herbert graduated from The University of the South, Sewanee, earning a Bachelor of Science in Political Science. While at Sewanee, he was a member of Phi Delta Theta fraternity, The Red Ribbon society, the Wellingtons, and the Order of Gownsmen. He spent 30 years with Harry Norman Realtors in Atlanta, Georgia as a managing broker, vice president, and later as partner. Herbert served on the Atlanta Board of Realtors as Young Realtors President, Agent Orientation Chairman, and on the Arbitration Committee. He also volunteered for Chris Kids (providing homes for homeless children), Big Brothers of Atlanta, March of Dimes, Special Olympics, and Meals on Wheels. Herbert and his wife, Libby, live in Highlands, North Carolina and Port St. Joe, Florida with Calvin and Baylee, their dogs. They are involved with several local non-profits. His hobbies include travel, fishing, and enjoying their five children and three grandchildren.

## Rob Haener, Class of '70

When Rob Haener entered CMA he was unsure of what he was getting into, but he knew it was away from his father, so he was excited to find out. Having been born in the Army (Ft. Benning) during the Korean War, and with the family's subsequent stationing at Ft. Knox, and with all his father's Army buddies (from WWII enlisted days) at the house now and then, Rob more or less felt at home with all the new stuff at CMA, unlike most of his



new student colleagues. That didn't stop him from thinking a couple of senior officers were sadistic rat finks, but as he says, on the whole he truly enjoyed himself and was gratified to make so many good friends so fast in his new environment. He thinks it was the camaraderie among the corps of cadets that cadets remember most. The high spots for Rob are his favorite stories to tell people about CMA, like the saga of Barley, Bonecutter and Cheese and the late night tire changing adventure in town followed by the woman they helped who wrote Commandant Howell to ask why the boys wouldn't give her their real names! And then there are the many stories from band trips on Ben's Big Banana Band Bus, and late night sneaking across the highway behind the campus to play pinball and eat burgers at the little beer joint back there (what was the name of that place?), and Pearl Murrell, the school nurse who was almost as tough as Master Sergeant Allen and had such an amazing history, just like him. Although many might not know it, she was a nurse in the London underground during WWII. She acted as doctor, nurse, song leader and trauma psychologist to people during the bombings in the Battle of Britain in those dark subway tunnels. Tough as nails. She put Rob's roommate, Tom Lanman, in an oatmeal bath for hours when he drank a soda (Dr Pepper) that had prune juice in it because of a serious allergy. Rob remembers Graham Hann, by far the greatest educator and best mentor of his life from CMA to the end of doctoral work. Head and shoulders above everyone. He started Rob writing, and he has been writing one way or another the rest of his life, including the 2 volume set of short stories he has been working on for 35 years or

so. (He thinks it may get published posthumously, if ever). Rob remembers W. D. Prickett, the original Georgia Bulldog (the model for Uga, ya know), who tried so hard to make the mysteries of algebra stay in Rob's head long enough to get through finals, and so many more real educators gathered at CMA. Rob believes the CMA Cadets really had a better chance to excel than just about anyone. After CMA, Rob was in pre-med and working two or more part-time jobs for 3 years, until he burned out completely and went out to find the highest paying job he could stomach. At Memphis State, he held as many as 3 part-time jobs at once, and even lived one semester in the back seat of his old Plymouth parked behind The Bull Shot, a bar on the Highland Strip in Memphis. The job he found after he left college was as an SEC registered rep (Series 7 Securities Broker-Dealer), and he did it as long as he could stand it. During this time, he married a wonderful girl and had two fine sons. He then did two years in Venezuela as a construction missionary, building food banks and medical clinics, and afterward entered seminary in Louisville, Kentucky. He finished his Bachelor's degree and did a huge Master of Divinity (148 hours) simultaneously, and went from there to Baylor in Texas for his doctorate. He was about to begin teaching at age 50 when his health just "went to pieces" (Legionnaires Disease, for one thing, with lots of complications). He retired early and moved to Virginia to live in the most beautiful hardwood forest he has ever seen anywhere in the world. Rob has been writing *amici curiae* for the US Supreme Court on Church-State cases for many years, and he continues to do so for several organizations. As soon as Rob got to Virginia, Andy Evans contacted him out of the blue, and they met near D.C. while Andy was setting up for a NASA program, and for Rob it was great to have contact with CMA people again. It was years before he was healthy enough to enjoy life again, but the loveliness of his place in the deep woods finally got him through it. Rob says he is very happy building wooden boats and furniture, tending his antique motorcycles and critters, and still working on that book.
