From the President



Bellhops, Faculty & Friends:

It is officially Summer as we just celebrated memorial Day. In honoring our military personnel who lost their lives in service to our country, I am proud of the large number of our fellow CMA brethren who served in our Armed Services and especially those who gave it all. At CMA, Memorial Day signaled the end of the school year and the beginning of three much anticipated months at home for summer vacation. Graduation at CMA was quite the occasion. There were so many activities including parades, drill competition, the dance, award ceremonies and the graduates receiving their diploma. We then had our final formation, playing of taps and being dismissed for the year.

The location of our 2020 Reunion was the main topic of discussion during our 2019 Spring Board of Directors meeting. VP Randy Howell, '72, headed a group to research the hotel. Restaurant and event locations in Columbia to determine if moving the 2020 Reunion back to Columbia was practical. With information and input from Woody Pettigrew, '73, who was organizing the Decade of the 70's Reunion, they reported that the move back to Columbia for 2020 was not practical at this time. The proposed new Marriott Courtyard in Columbia may be the missing piece to our puzzle in moving back to Columbia in 2022. We will hold the 2020 Reunion at the Marriott in Cool Springs. Details to follow.

Lisa Bennett, CA VP for Development, addressed the Board in Dr. Thomas's absence. You can read her comments in the board meeting minutes in this copy of the *Bugle*. Lisa is one of the main parts of the CA Administration and Faculty who help maintain our relationship with CA and have the access to the campus.

The Board voted once again to donate a \$1,500 scholarship to a deserving CA student. I asked the Board members to consider donating to the CMAAA general Fund to help cover the cost of the scholarship. We received \$770 in donations with another \$250 pledged. If you would like to donate to the scholarship fund, please send a check nade out to CMAAA to Becky Moon at the CMAAA address in the Bugle, with a note on the check that it is for the Scholarship Fund. Donations are tax deductible. Any amount received over the \$1,500 goal will go toward the 2020 scholarship.

The Board voted to honor our CMA Valedictorians and Salutatorians during our 2020 reunion. This is an elite group who we all admired.

Looking forward to the 2020 Reunion, my main concern is attendance. As the years pass, many of our older members have passed away and many more are unable to travel and participate in CMAAA events. We need to ensure good participation from the grads from

the 1960s and 1970s. The recent Decade of the 70's reunion had 100 alumni and guests. Meeting Minutes

The CMAAA Board meeting was called to order at 9:15 AM on Saturday 4, 2019. The meeting began with a moment of silence in remembrance of board members and association members who have passed, as well as, present members who are in ill health. The Invocation was given by Van McMinn and Mike Gilchrist led the Pledge of Allegiance.

There was a motion made to approve the minutes from the October 27, 2018 Board Meeting. The motion was seconded and approved by the board. Rebecca Moon gave the Treasurer's report and stated that we brought in \$26,000 at our last reunion. The expenses ran about \$21,000, leaving us with \$5,000 to be used toward other expenses for the Association. The cost of the Bugle runs about \$1,600 a year and the scholarship sponsorship is \$1,500. Our association will definitely need to be looking at ways to raise monev so we will be able to cover expenses for future events. She made the point that with our association numbers dwindling and no new prospects being added, our monetary sources are limited. We have an operating amount in our checking account equaling around \$27,167.41. Robin Salze gave the Museum report. We have a balance of \$17, 389.49, which Woody has stated as being a sufficient amount in the budget to maintain operations of the Museum for the duration of the lease. This amount will go a long way to fund the two fiveyear options. The Museum account is in good shape .

Robin introduced Lisa Bennett, VP of CA, who was there to represent Dr. Thomas, who was unable to be present for the meeting. She emphasized how much she loves CA and feels appreciative that we share the history of CMA. She stated that the faculty and staff of CA wish to continue being good stewards of caring for and maintaining the campus and existing buildings. Academy Hall is one such building that she mentioned and their hope is to renovate the second and third floors. The first floor has been renovated and is now being utilized for offices. She expressed appreciation for the CMA Endowment Fund which helps with this endeavor. This fund helps with maintaining buildings on campus and any possible renovating that may need to be done. She reiterated how important these buildings are and how much the people of Maury County love having this historical campus as a part of their community. She said she appreciated that so many former cadets come back to visit and that CA Day has become such a successful way to share past experiences and traditions of CMA with their present student body. The students have enjoyed learning about what the school was like years ago. And it's such a privilege for the students to engage in conversation with the former cadets, to hear their stories and what life was like while living on campus or attending classes during a time when life was so different from what it is today. She closed in stating that CA will always welcome us anytime and that they are very thankful for the relationship we have. Robin added that Dr. Thomas and Lisa Bennett, along with the Administration of CA, are always willing to do anything they can to accommodate our Association. We are appreciative of this.

Before continuing the meeting, Robin shared the loss of another member of our Association. Wiley Abernathy, class of 55, passed away Saturday, April 27.

Old Business

First on the agenda was the discussion of Columbia area facilities for the 2020 Grand Reunion. Everyone has shown great interest in bringing all the festivities back to Columbia. Both Randy Howell and Woody Pettigrew (searched

for such facilities for the 70's gathering) have done a lot of research on this matter. It has been determined that the Saturn Hall is available and the cost would be about \$5,000. This is not including catering or other expenses. The key is having facilities that can house all those attending and a central location for our Registration, Memorabilia and Reunion. A statement was made that as much as it would be great to have everything back in Columbia, everything would have to spread out. Because at this time, there is no facility available that would be able to accommodate us like the Marriott has. Everything is under one roof and they have been very helpful providing the rooms needed to host our Reunion. And when the Reunion is relocated from the Marriott to Columbia, and the banquet is moved to the Saturn Hall, there will be a need for more volunteers. Becky Moon made a point emphasizing that Columbia does not have any facilities at this time that can conveniently keep our festivities in one location. Becky also said that it is a tremendous job orchestrating preparations for the Reunion and that moving the

2020 Reunion to Columbia would not be the best option at this time. There is a new hotel opening in Columbia that will hopefully be ready by the 2022 Reunion, so moving the Reunion to Columbia would be something to consider then. Robin suggested that in the best interest of the Association, we should hold the 2020 Grand Reunion at the Marriott, but readdress the possibility of moving back to Columbia for our 2022 gathering. Board members who are residing in Columbia can continue to monitor the progress of the new facility and keep the Board updated on the status of new developments. Once a time table for completion is known, then we will need to get in contact with them a soon as possible, in order to make plans for accommodations and to ensure that holding our event there could be a possibility. A motion was made that we remain at the Marriott for our 2020 Reunion. The motion was seconded and approved by the Board.

The next topic of discussion was concerning holding an auction at the next Reunion. There was some debate over which would be best; to hold an auction or sell raffle tickets. Steven Watts has offered donating an M1 Garand, which is a type of WWll rifle. He said he could

have the CMA logo engraved on the stock. He also felt that selling raffle tickets would be a better way to raise more money. A suggestion was made that if an auction is held, we would need more than one item, and therefore would need to ask for donations of items to auction off. This request could be made in the Bugle. Becky reiterated that our 2018 Reunion had the lowest number of attendees thus far and that this definitely showed our numbers are dwindling. We were barely able to cover expenses at our last reunion. She expressed the importance of raising enough money to cover expenses that will be expected in 2020. Raising the registration fee could be an option, but having an auction or selling raffle tickets would be great way to help alleviate the possibility of not having enough money to cover costs. Another idea was to enlarge class pictures and auction them off. After much discussion, the Board decided that it may be best to follow through on selling raffle tickets for the rifle; \$25 each, or five for \$100, and then asking for donations and continuing the collection of those items for auctioning at the 2020 Reunion. The drawing of the raffle ticket will also be held at the reunion. A motion was made to sell raffle tickets for Steven's rifle and to pursue collecting items for holding an auction at our next reunion in 2020. The motion was seconded and approved by the Board. Bill Wade made the suggestion that when we set things up to be auctioned at the reunion, there should be an initial amount to begin the bidding.

Next on the agenda was the restoration plans for the Cannon. Mike Glover and Woody Pettigrew had begun checking on the cost of having this done. Woody checked with someone who had previously worked to repair it and he has agreed to do the wood restoration on the wheels and the ammo box. The cost was estimated to be between \$1,000 and \$1,500. The Museum Account has enough money to cover the expense of having the restoration done.

New Business

There is no class representative for the classes of 1970 and 1971 at this time. Robin also stated that we have no one from these classes represented on the Board. He said he will be sending

emails to those attending reunions from these classes to request volunteers who may be interested in representing their class at the 2020 Reunion.

Ideas for the honor group for 2020 were discussed. It was decided that Valedictorians and Salutatorians would be recognized at the 2020 Reunion. The motion was made, seconded, and approved by the Board. Our final topic of discussion involved the CA Scholarship, which is presented to a deserving student each year. Robin wanted to make the Association aware that donations to help with this award would be very much appreciated especially since our budget is tight and the scholarship is given out of the General Fund. If donations are sent to Becky Moon, just specify that it should go toward the Scholarship Fund. A suggestion was made to have a bowl set up for donations at the 2020 Reunion and these donations would go specifically toward future Scholarship funding. A motion was made to give \$1,500 from the General Fund to the CA Scholarship Fund. This motion was seconded, and approved. Last year's recipient went into the Air Force Academy for basic training in July 2018

Mike Gilchrist shared a request made by a mother of a former student who attended CMA two years and graduated in 1967. The mother of Emory McNoldy had asked that if it was at all possible to scatter some of her son's ashes somewhere on the campus. She was advised to contact Dr. Thomas and make him aware of her request and to confirm that this was something that could be legally done. It was decided, upon Dr. Thomas's approval, that this could be done on the upcoming CMA Day in the fall of 2019. She also donated a few of his belongings, including a saber and several pieces of brass.

Mike Gilchrist was asked to give the closing prayer. Before adjourning, Becky Moon suggested that we begin our upcoming Board meetings at 10:00 as opposed to 9:00 and this was agreed upon unanimously. The meeting was adjourned at 10:20 AM.

CMA Spellunkers

As foolish things frequently originated in the dorm, someone said, "Why don't we go check out this cave that he had been told about that's on some farmland not too far away from the campus? Sounds like fun said the group who had heard the comment from one of their friends in the dorm. We can go this next Saturday afternoon, everyone agreed. So arrangements were made for getting a ride out to the cave, a mile or so north from the campus by the railroad tracks that would get us right back to the campus when we got out of the cave since we would not have anyone available to bring us back. We walked a lot back in those days. No one in earlier times at CMA had a car available, unless you knew a local girl, or a "townee". But, regardless, transportation to the cave was arranged. On the next Saturday just after lunch, we all assembled for the ride to the cave.

At the cave, we found the semiconcealed entrance a little overgrown by trees and vines, and there may have been a small stream of water trickling out that ran off down a pasture from the entrance. The initial entrance was easy once you got past the external growth. The cave started with a big room like entrance. Then it immediately closed down to a narrow opening that we had to crawl through on our hands and knees. All the surfaces were solid rock, like nothing we had ever seen. By this time we were using out flashlights to see what was around us. After the crawl, we found we were in a big cavern like room that we could walk around in, upright with no problem. There was a small pool of water that trickled out toward the entrance. Going a little further into the cave, someone questioned how were we going to remember how to get out? Good question. There were no markers provided anywhere. So by this time, it dawned on the group that we did not need to try to explore the possible interior depths of the cave. There was a good chance we would get lost and who knew that we were in there? No one.

That determination led the group to appreciate that we didn't know anything about spelunking, which at that time, we did not even know there was a word for cave explorers. So we started working

our way back out of the cave, just like we came in. By the time that we got outside, someone looked at their watch and realized that we had taken longer inside the cave than anticipated even though we had not explored too deeply. We were going to have a tough time getting back to CMA for retreat formation and the dinner meal. Of course, we were going to follow the railroad back to the campus, but actually how far away were we? No one knew. For me, not wanting to be absent from the formation and roll call with ensuing demerits and the bull ring were not anything anyone looked forward to. While no one in the school administration had ever told us not to go out cave exploring, it would not be looked on favorably for doing so, and being late in returning. So we ran, virtually all the way back to the campus and everyone made it, cleaned up and in uniform. for the formation, just in the nick of time. That was enough speelunking for me.
