Bill began serving as the editor of the Bugle, taking over from Jack Muth, '67, with the publication of the Spring 2001 Bugle. As the Bugle's second editor, Bill worked diligently to improve it with each edition, ever striving to accomplish the objective of supporting the CMA Alumni Association members' unity and heritage. Bill has taken pictures, written articles, collected input, edited submitted articles, developed inserts, researched newspapers, converted electrons, struggled with format, devoted untold hours, and probably spent more than a couple of dollars; all with one purpose... to provide members of the CMA Alumni Association with the best product he possibly could so we could all have a quarterly stroll down memory lane as we read the next edition of the *Bugle*.

In addition to "retiring" as editor of the Bugle, Bill is also handing over responsibility for the maintenance of the CMAAA Website. The web site is an offshoot of a program initiated when Robin Layton was President of the Alumni Association. That program was initially designed to introduce Maury County visitors to a visual history of CMA. Greg Thompson, '72, proposed the development of a Kiosk to present the CMA story and then developed the Kiosk that served the association with our initial Museum efforts in the War Memorial Building. Bill adapted that work and expanded it to become the CMA Website. He is directly responsible for the layout, content, and update of information on the website, to include maintaining the Directory database which is probably the most used portion of the website. Maintaining the website is another area where Bill has devoted significant time and energy so all alumni and friends of CMA can have ready access to CMA information.

Bill has been planning to execute these transitions for almost two years, but has patiently waited until the time was right. For those who attended the Saturday Night Dinner at the 2010 Reunion, you know that the Association presented Bill with a set of wooden CMA bookends that were especially

Meeting Minutes

The meeting was called to order by President Don Kimbrell ('53). The Invocation was given by Randy Howell ('72). The Pledge of Allegiance was led by John Bass ('53).

A motion was made, seconded, and approved to accept the minutes of the 9 April 2011 CMAAA Board of Directors meeting as published in the Spring 2011 *Bugle*.

Treasurer's Report

Becky Moon ('75), Assistant Treasurer, gave the Treasurer Report. There is \$27,915.85 in the regular checking account. The Reunion cost is now higher than the Reunion income due to our not making any money on the food or drink at the Reception and Banquet. Becky suggested we consider raising fees and purchasing new souvenirs to enhance our income. There was extensive discussion about dues collection and how it can be improved. Bill Raiford ('55) will mail cards to all Alumni in an effort to enhance the dues collection. A motion was made, seconded and approved to accept the Treasurer's report.

Woody Pettigrew ('73) gave a re-

port on the state of the Museum. The Museum currently has \$18,463.54 in its account. The projected additional revenue is \$20,045.00 and projected expenses are \$28,950.00 resulting in a \$9,558.54 surplus. Fundraising will continue as there may be unexpected expenses and to support the likely desire to execute the two five year lease options we have on the Museum.

Old Business

Woody Pettigrew withdrew his "50 for 50" proposal, which was presented to the Board during the past two Board Meetings and never acted on.

New Business

Woody Pettigrew reported that CA has partially restored the water fountain which was by the quadrangle and will let CMAAA have it to install in a location to be determined. Woody gave the Board several ideas for locations; an area in front of the Museum, the original location by the quadrangle, or in some area of the new CA Complex by the football field.

Woody Pettigrew reported that the names of the new Hall of Honor Members have been added to the memorial.

Bill Raiford ('55) asked for all members to assist in completing the list of CMA Alumni.

Don Kimbrell reported that the Embassy Suites has quoted us a price of \$119.00 per room, up from \$89.00 per room during the 2010 Reunion. They also will raise the Friday night reception by \$5.00 per attendee. The Saturday night Banquet will remain the same cost. Embassy Suites room cost does include breakfast each morning and a manager's free reception every evening.

The Marriott has given us an offer of \$89.00 per room. The Marriott does not have the first week-end August date available. They have the weekend of August 24, or the weekend of July 21.

There was a lengthy discussion concerning the details of what is available at each Hotel. Two major differences between the hotels is the nightly manager's reception which is available at the Embassy Suites and not at the Marriott and the free breakfast that is available at the Embassy Suites and not at the Marriott.

The Board agreed to not have a reserved room for the Friday night re-

ception, but have a hospitality room for registration use and to conduct the Friday night reception in the large open area of the hotel with no special or'dourves or beverages, and at no cost to attendees.

The overall response was so positive to the Embassy Suites experience from the 2010 Reunion that the Board members agreed we would like to use the Embassy Suites again if a better rate could be negotiated .

A motion was made to have Don Kimbrell, Tom Walbert ('58) and Ron Nall ('61) approach The Embassy Suites and negotiate a lower rate if possible, and report back to the Board via email with our options with both hotels. The motion was seconded and passed.

A motion was made to amend the By Laws Reunion date requirement of the first week end in August due to the possibility of the date not being available. The motion was seconded and passed.

A motion was made to suspend the By Laws requirement regarding the first week end date in August instead of amending the By Laws. The motion was seconded and passed, which will supersede the prior motion.

Bill Wade ('68) discussed the pros and cons of the Reunion Golf Tournament. The board agreed to plan a golf outing in conjunction with the Reunion; participation level will determine if it will be set up as a tournament or just a time for interested alumni to gather and play a round of golf. Bill and Randy Howell will head up the effort.

There was a discussion of using a band or DJ for the Saturday night Banquet. Due to the significant cost of a band there was a consensus to use a DJ. Randy Howell reported that the DJ would be donated for the Banquet.

There was a discussion of having a silent auction or raffle to raise money during the reunion weekend. Board Members were asked to explore options and make recommendations at the next Board meeting.

Becky Moon stated that we must ensure we charge attendees enough to cover the cost of the Saturday night Banquet.

Winston Elston made a motion we use "Military Aviation" for The Reunion Theme. The motion was seconded and passed.

Randy Howell offered a closing prayer for dismissal and lunch.



The plaque shown above was made to honor the CMA cadets that made the ultimate sacrifice in World War II. This picture of the plaque was taken out of the 1960 Recall, where it was included as a tribute to those former cadets. This is one of the items that we have been trying to locate for the CMA Museum but to this point we have not had any success.

The latest information available on the plaque is that it was seen in the Peep Inn (across the train tracks from Main Building) in 1991 when the CMA Alumni Association Board of Directors was looking at Peep Inn as a potential building for the Association to use as a headquarters. At that time the plaque was in the building, along with guidons and numerous other CMA artifacts. There is no information on what happened to those items but it is possible they were transferred to Amon Evan's property for storage at some point.

CMA Museum Update





Original CMA Water Fountain. The picture on the left is from the 1959 Recall and shows one of the old water fountains that was located on the CMA Campus, this one being on the Quadrangle. The picture on the right was recently taken and is possibly the same water fountain after years of neglect and enduring at least one flood while in storage in the basement of Johnson Hall.

The CMA Museum has now been operational for a little over three years. A large number of alumni, former faculty, family members, and tour groups have visited the Museum since its opening during the 2008 CMA Reunion and feedback continues to be positive. The displays have withstood the test of time and the Museum continues to receive new items for display.

As highlighted in the last Bugle, work was done to the windows and gutters of the Museum by the 2011 Bullring Crew over the Summer. That work will help preserve the building as well as improve its outside appearance. Plans are being made to have a few more workdays in the Spring and Summer of 2012 to get the Museum in the best shape possible for the Reunion. The plan is to repaint the porch ceiling and the trim inside the museum, clean the cannon and caisson and the pad they are displayed on, thoroughly clean the inside of the center and wall showcases, and update displays as necessary.

Columbia Academy recently asked if the CMA Museum would be interested in having one of the old water fountains from the campus. The water fountain has been in storage in the basement of Johnson Hall for a number of years and is in need of restoration but it appears to be a worthwhile venture. The Board will determine an appropri-

ate location to display the water fountain at its Spring meeting so the fountain can be restored (aesthetically) and displayed prior to the August Reunion.

The CMA Museum maintains a budget separate from the CMAAA General Fund. That budget is presented to the CMAAA Board at each meeting, most recently on October 8th, 2011. A summary of the budget through the year 2022 is below:

John Glenn becomes the first American to orbit the Earth, and does so three times in 4 hours, 55 minutes on February 20th 1962.

60 Years Ago Winter 1951-52



The Los Angeles Rams defeat the Cleveland Browns 24-17 for the NFL Championship on December 23, 1951. This Championship Game was the first one televised coast-to-coast.

The Marshall Plan expires in December 1951 after providing more than \$13 billion in aid to rebuild Europe.

Dragnet, starring Jack Webb, premiers on NBC TV on January 3rd 1952.

At CMA, The Gold Star Drill Platoon, organized at CMA for the first time in October 1951, was fine-tuning its skills for a promising first year.

40 Years Ago Winter 1971-72



In the longest game in NFL history, the Miami Dolphins beat the Kansas City Chiefs 27-24 in double overtime in a Divisional Playoff Game on December 25th 1971.

The first scientific hand-held calculator (HP-35) is introduced on January 4th 1972 (price \$395).

David Bowie opened his concert tour with his new alter ego "Ziggy Stardust" on February 10th 1972.

At CMA, Terry Briggs is settling in as Battalion Commander, the third Briggs to hold that position, following in the footsteps of Richard Briggs ('66) and David Briggs ('68).

William Hadley Thompson, CMA Class of 43, died October 15, 2011 at the age of 86 in Denver, Colorado following a brief illness. He was born in Memphis, Tennessee on June 12, 1925 to Vance Maynard Thompson, Sr. and Elizabeth Greer Thompson. He attended elementary school in McCrory, Arkansas and was a graduate of Columbia Military Academy in Columbia, Tennessee. He attended Vanderbilt University prior to serving in the Army during World War II. During his basic training he was stationed out west and it was during that time he developed a love for the mountains and snow skiing. He was also a graduate of the Parsons School of Design in New York and owned and operated an antiques store in Little Rock, Arkansas and later in Telluride, Colorado. He was active in community affairs in Telluride having served on the Historical and Restoration Commission approving restoration of original structures and the construction of homes and businesses in town that were in keeping with the historical setting.
