From the President



Cadets – Once again it is that time of year when we think back to the cadence call of “Hark the herald Angels shout, (fill in the number) more days and we’ll be out”. Well I remember one year when the school did not shut down for Christmas. As a matter of fact it became a hotel overnight for stranded motorists. It was in the early sixties and it was close to Christmas night. A horrible snow storm came upon the sleepy village of Columbia and Highway 31 (I-65 was not built yet) was closed down. The local hotels quickly filled and my father was called by the Holiday Inn and the Highway Patrol to see if he could open one of the cadet “barracks” for stranded motorists. He agreed and opened North Jackson and, with the help of the Holiday Inn linens, my family quickly turned the rooms into a hotel so that stranded families would have a place to stay that night. Soon the Highway Patrol arrived in the dark of night leading a convoy of several cars on campus and the CMA saved the day. It

Meeting Minutes

The fall meeting of the Columbia Military Academy Alumni Association was called to order by association President, Mike Gilchrist. There were 21 board members and officers present along with Past Presidents Don Kimbrell (‘53), Bill Raiford (‘55), Bill Hart (‘62) and Robin Layton (‘74) and guests Ed Lawing (‘74), CA President James Thomas and friend of the board Buddy Fisher. The Pledge of Allegiance was led by John Bass and the invocation was given by Don Kimbrell.

Welcome and CA Update

Dr. Thomas welcomed the association

and guests back to the campus and provided an update on Columbia Academy happenings. He was excited to report that the enrollment for the fall term is a new record for CA with 839 students, 95 of which are at the Spring Hill campus. This is a 10% increase over last year, and places CA second only to David Lipscomb in enrollment for Church of Christ schools in the state. The CA football team has been doing very well with a 6-1 record (10-2 as of this writing). Dr. Thomas invited the board to go see “Winston”, the statue of the CA Bulldog, located in the front of the new Anderson Field House. Winston was named by a student body election in 1999. Dr. Thomas stated that the CA staff and student body were excited about this year’s homecoming festivities. He also informed the board of the newly established CA Hall of Fame and reported 6 Inductees were included in the first class. On a sad note, Dr. Thomas reported that due to structural failures and many other long-termed issues, plans have been made to demolish Moore Hall, one of the original CMA buildings. After extensive studies of the building, it was determined that it is unsafe and beyond reasonable repair. While this was a disappointing announcement, many of the CMAAA board members knew of the poor condition of the building and agreed it was the right move to make. Dr. Thomas spoke to the condition of other buildings on campus and stated that Johnson and Jackson are still in good shape with only normal repairs needed to maintain them. Even though Frierson is not in

good condition, there are no plans to demolish that building in the foreseeable future. Dr. Thomas then informed the association of the establishment of the Columbia Military Academy Endowment. A CA graduate made the initial \$10,000 donation to establish the endowment that is focused solely on preserving the history of Columbia Military Academy. While CA will manage the endowment, it is specifically limited to funding activities that preserve the CMA History (Museum, Memorial, Flag Pole, banners, etc.). He provided the board members a copy of a draft letter setting up the endowment and asked the board to review and make recommendations to him on potential revisions to the letter. Mike Gilchrist asked Ron Nall ('61), Bill Wade ('66), Woody Pettigrew ('73) and Robin Layton ('74) to serve on a committee to review the letter and make recommended revisions to present to the board. Dr. Thomas asked that the board get back with him after its next meeting and let him know the results of the review. Once the endowment is formally established, anyone wishing to contribute can send their donations to Columbia Academy and note on the check that it is for the CMA Endowment. As CA does have the tax exempt status, all donations to the CMA endowment are tax deductible. More information will be provided in later editions of the *Bugle* newsletter.

Motion made, seconded and passed to accept the minutes from the last board meeting.

The Treasurer's Report was given by Becky Moon. As of September 30, 2013, the balance of the CMAAA General Fund is \$39,462. Becky responded to questions regarding the cost of mailing the quarterly *Bugle*. Currently it is costing between \$1,500 and \$1,600 dollars. Once again we were asked to notify Becky if we no longer wanted the paper copy of the *Bugle* since it would save some of the cost of mailing. Later discussion regarding finances included the fact that we currently have 1,452 alumni on the active list. Of that group, only 397 are current with their dues. There was discussion about the potential of being able to pay dues electronically, possibly through the CMAAA

website, using PayPal or other methods. Woody Pettigrew issued the report on the CMA Museum account. We are in good shape with a current available balance of \$11,765.44. Woody also noted that the projected sales of ornaments would not likely meet the designated amount of \$2,574, but that overall the museum budget is in good shape. Expected donations and revenue from raffles and auctions at reunions will make up the shortfall of ornament sales.

Old Business

Mike Gilchrist informed the board that he has been in contact with David White of White's Camera Shop regarding the negatives obtained from Orman's after Mr. Burt's passing. CMAAA offered Mrs. Burt \$5,000 for any and all negatives pertaining to CMA and the cadets. David informed Mike that he is approximately six weeks behind in sorting the negatives due to some family obligations, but he expects to be able to give us more information by the spring board meeting. The \$5,000 has not yet been paid to Mrs. Burt pending the results of the sorting of the negatives.

A lightweight jacket was shown to the board which had the CMA cross rifle logo. Buddy Fisher, friend of the board and son of former faculty member John Fisher, had donated the jacket to the Museum. Becky Moon agreed to have a prototype made of a jacket similar to the one presented and she will advise of the cost and see what the interest is in having several made to sell.

The committee assigned to research the possibilities of the location for the 2014 Grand Reunion came back with the decision to go with the Marriott in Cool Springs. The location is very close to the Embassy Suites which we have used in the past two reunions. The board voted unanimously to use the Marriott for the next reunion.

Related Reunion Planning

Part of the discussion for the upcoming reunion pertained to the Friday night reception. The Marriott agreed to consider providing snacks for that evening for a fee of \$500. That has not been finalized at this time.

A website has been set up for the hotel registration for the reunion. There will be 3 areas available for reunion dinners for classes that would like

to have a get together. It will be first come – first serve. However, the board agreed that first right of refusal should go to those groups celebrating anniversary years, such as 1953/54, 1963/64 and 1973/74.

At the Grand Reunion we will be recognizing those who were named as Mr. or Miss CMA through the years. It is the board's desire to make the recognitions during the Saturday night event rather than the meeting Saturday morning. For the former Mr./Miss CMAs that are deceased we would recognize any family members that attend. Mike Gilchrist will generate a letter to be sent to these individuals asking them to attend the reunion.

Mike Gilchrist will check to see if David White has an interest in doing the class photos for the reunion.

This year, due to the Marriott giving us free nights based on the number of rooms we use, we will try to give a free night to the person traveling the longest distance to the reunion and to the oldest alum in attendance. This will of course depend on the registration numbers.

New Business

The CMA banners that are hanging around the Quadrangle are ready to be replaced. The last time we replaced the banners the cost was approximately \$3,000. Woody Pettigrew noted that we need to ensure that the poles holding the banners are fixed before we spend the money to buy new ones; that effort is a CA responsibility. Mike Gilchrist asked Woody Pettigrew to get with the vendor for the banners and determine the cost to replace them in time for the reunion.

Woody Pettigrew is going to set a weekend in the Spring for cleaning and repair work on the CMA Museum. This is an annual event that has drawn great support from association members. The next session will include paint touch-up, display cleaning, landscaping and painting the cannon and caisson. This may be set up to coincide with the Spring Board meeting.

Woody announced that all CMA year-books from 1953 to 1979 are now on the CMAAA website. He suggested they be downloaded onto your personal system in order to view more quickly.

Motion was made, seconded and passed to adjourn the meeting.

We had a very good quarterly meeting in October discussing plans for our Grand Reunion in 2014 along with some other items of note. Those who played also reported that we are very fortunate to still have our school in tact as our colleagues from Heights will lose the last part of their school as the restaurant in their main building closes in the near future. I once again want to encourage those who have not been to the school lately to visit if you are in the area. I believe you will be pleased with what you see.

Our board decided that the 2014 Grand Reunion will be at the Marriott Hotel and Convention Center in Cool Springs instead of the Embassy Suites. The Marriott is across the street from the Embassy Suites and is offering the same rate with a full cooked to order breakfast. They will also provide us with private rooms in the convention center at no charge for our reception on Friday night and our Banquet on Saturday night along with an area that can be locked up overnight during our reunion so we can leave the memorabilia and registration information out instead of taking it up every evening. We will also have a private area for our Friday afternoon board meeting. The Embassy was going to charge a fee for all the extra room requirements as well as less options for reservations. The Marriott provided all the extras free of charge. Overall it was agreed that Marriott offer was the best choice.

Another item of note is that Dr Thomas, the current President of Columbia Academy, reported to the CMAAA Board of a decision by the Columbia Academy Board to take down Moore Hall. This became necessary because the building is no longer safe and the price to restore it is cost prohibitive. He pointed out this was a very difficult decision to make but they had to take some action before someone got hurt. There is more on this subject in the

minutes of the association meeting along with Dr Thomas' statement concerning the issue

Dr Thomas also advised our board that he has started an initiative to create a CMA Endowment Fund. The purpose of the endowment will be to preserve the original CMA buildings and grounds. He said that he already had a Columbia Academy donor ready to give \$10,000 to start the CMA Endowment. I've asked Woody Pettigrew, the association historian, to head up a committee to work the details of the endowment fund with Dr Thomas and report to the board at the Spring Meeting and our full association at our Grand Reunion in August 2014. There is more information on this initiative in the minutes of the association as well.

Well, as you can see our October meeting was quite busy. In the coming months we will be planning further for the grand reunion and will provide more information as it becomes available. I want to once again encourage those who could not make it last time along with those of you who did to plan to attend to renew old friendships and see the current school that shaped many of our futures

Finally, I want to take this opportunity to thank each one of you for your support to our association over the last year and hope that you and your families have the happiest of holidays.

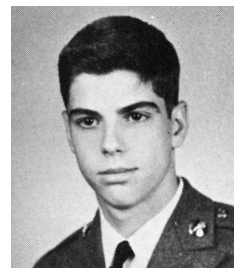

Open Letter to all CMA Alumni

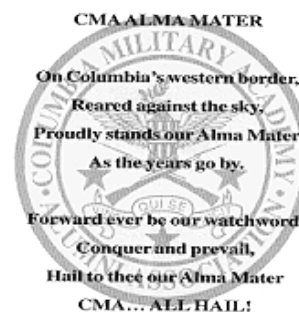

Fall 1953



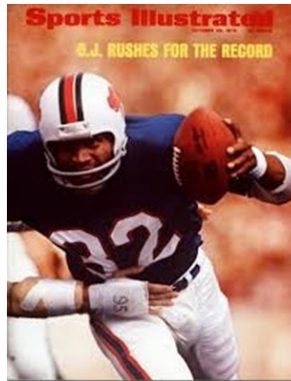
Earl Warren is appointed Chief Justice of the United States by President Dwight D. Eisenhower on 5 October.

Then and Now

Sam Paplanus, Class of '46

Although his family lived in Winchester, Sam was born in Columbia at the King's Daughters' Hospital. He grew up in Winchester and attended school there through the 10th grade. He then transferred to CMA in 1944; he lived with his grandfather on Athenaeum Street and commuted by bicycle to the CMA campus. He did live on the campus during the 1945 summer session. There were things about his CMA academic experience that Sam still remembers and values. Major Fishburne taught Sam's physics class; when he later took introductory physics at Vanderbilt he found that he already knew almost everything that was being taught, courtesy of Major Fishburne. Sam also thoroughly enjoyed his mathematics courses, especially the advanced courses taught by Colonel C.A. Ragsdale. Sam's decision to major in mathematics at Vanderbilt was at least in part due to that experience. The cadets in Sam's senior English course were required to memorize "L'Allegro" by John Milton – not a short poem. Sam still remembers it; when he recently underwent an MRI which required him to spend many minutes in a confined tube-like space he found himself making the time pass by reciting "Hence, loathed Melancholy, Of Cerberus and blackest Midnight born, In Stygian cave forlorn,..." and so on for many lines. Sam graduated from CMA in 1946 as the Class Salutatorian. He went on to Vanderbilt, graduating in 1950 with a mathematics major. He then spent four years at Vanderbilt Medical School and decided to specialize in Pathology. He finished his residency at Vanderbilt as chief resident in Pathology in 1957. After that it was off to the Army for two years. After a 6 week orientation course at Fort Sam Houston, Sam was assigned to the Army Chemical Center in Edgewood Maryland. He developed an interest in infectious diseases and in 1959 he took a one year fellowship at Yale in the infectious disease section of the Internal Medicine Department where he contributed to some published work on kidney infections. After that, Sam took a two year fellowship at Johns Hopkins Pathology Department continuing his in-



fectious disease work. He was asked to stay on after the fellowship in 1962 so he spent 10 more years on the Pathology faculty at the Johns Hopkins Medical School and the Medical Staff at Johns Hopkins Hospital. During that time, Sam became intrigued by a device called a "computer" (those CMA math courses were beginning to pay off). He developed a system of storage and retrieval of pathology information using "natural language" (English language, no numeric codes). Sam moved to Tucson to the Pathology faculty at the University of Arizona and the Medical staff of University Hospital in 1972. He continued and expanded his computer related work as well as being a Surgical Pathologist. He retired in 1990 as Professor Emeritus of Pathology. Since retiring Sam has kept busy as a member of the Pima County Medical Society, where he has been a long time member of the Public Health and History Committees as well as having been the Chair of the Alternative Medicine Committee. Sam has long been interested in the outdoors and has camped extensively in Arizona, Utah, Wyoming, Colorado and California. It was after a 1967 raft trip down the Colorado River through the Grand Canyon that Sam decided to explore a move to the Southwest (Baltimore had nothing like that!). He has also taken advantage of Elderhostel with trips to Turkey and other places. Sam says that all in all he has had a pretty busy existence and now that the inevitable infirmities are beginning to take over, regrets are few.



Marvin Vernon, Class of '57

In the Fall of 1953 Marvin decided to attend CMA as a 9th grade freshman due to Jackson, Mississippi having only one overcrowded high school. The plan was to return to Jackson as soon as a new high school was completed the following year. After a visit from Colonel Ragsdale that summer, it was decided Marvin would return to Columbia. Ragsdale promised Marvin the rank of PFC! Strangely, Marvin never was a PFC..... went directly to Corporal. Woopie, he was off and running. Four years later in 1956-



1957 Marvin was named Company Commander and Captain of Band Company. After graduation, Marvin attended the University of Mississippi majoring in Insurance. Marvin was married to his precious wife Lemma Ann Grantham in the summer between his junior and senior years at Ole Miss. They had three wonderful children over the next eight years; Gene, Laura, and Ken. Ken produced their only grandchild, Presley Ann, in 2006 (pictured herein with Marvin). He entered the life and health insurance business upon graduating from Ole Miss, first selling insurance in Jackson. He and his family then moved to Omaha, Nebraska in 1970 working in the Marketing Department of Mutual and United of Omaha. After four years there, Marvin accepted a position in Topeka, Kansas as vice-president of pension marketing at Security Benefit Life. Like other young cadets, there were some setbacks and hard lessons to be learned. He certainly didn't realize it at the time, but the next four years of new found discipline, academics, responsibility and motivation were invaluable and contributed greatly to a successful future career and family. "CMA treated all of us pretty much the same. For the first time, I felt really good about myself. Friendships made with fellow cadets and their families, both local and on campus, have carried on to this day".

Jim also learned quickly the hard way that "local town dogs" had the same rules, demerits, drills, Saturday morning school, night school, bull ring tours etc. as on campus cadets; caught out in town out of uniform on dates, turned in for tossing snow balls from the tennis courts at passing L&N train engineers/conductors, and more. Like many, a bit more stripes came and went, bull ring hours were racked up. However, early in his junior year, a bit more maturity set in and a more serious attitude about the future came forth. Senior year 1961 was a lot of fun as well as rewarding; B company was named "Efficiency Company". New cadets wanted to be in the "B-country club". Jim and friend Charlie Walters had both become converted/"good boys" working their way back up the ladder as the 2 platoon sergeants. Richard Oates was company commander along with Jim Whitmer and Bill Orman as platoon leaders, double date sidekick "Aldy" Bobby Alderson the company first sergeant. What a group that was! Jim graduated from MTSU in 1966 and was commissioned an officer in the Army via the ROTC program. Jim's four years at CMA allowed him to waive the basic ROTC requirements but he stayed involved with the department as a sophomore getting to know the advanced cadets and staff. Campus Happenings

For the 2013-2014 school year, Columbia Academy reports a school record enrollment of 841 students with a total of 152 new students in grades K - 12. This enrollment breaks the previous record of 825 students enrolled more than 10 years ago in 2001. Economic challenges over the years have taxed many private schools nationwide, but President Dr. James Thomas is encouraged by the continuing growth seen at Columbia Academy over the past three years. This record enrollment growth comes on the heels of the opening of the new Anderson Fieldhouse athletic facility, which opened in January of 2013. Other factors which may have contributed to the growth, Thomas said, also include the one-to-one iPad technology initiative, the increase of college credit options for high school students, rising college placement and TCAP scores, the Spring Hill satellite campus, and improved extracurricular options for students such as theatre and band.
